DECISION

Dispute Codes: OPR, MNR

This matter proceeded by way of Direct Request Proceeding, pursuant to section 55(4) of the Act, and dealt with an Application for Dispute Resolution by the landlord for an order of possession and a monetary order for unpaid rent.

The landlord submitted a signed Proof of Service of the Notice of Direct Request Proceeding which declares that on August 27, 2014, the landlord personally served each tenant with the Notice of Direct Request Proceeding.

Issues to be Decided

Is the landlord entitled to an order of possession? Is the landlord entitled to a monetary order for unpaid rent?

Background and Evidence

The landlord submitted the following evidentiary material:

- A copy of the Proof of Service of the Notice of Direct Request Proceeding;
- A copy of the residential tenancy agreement which was signed by the parties on February 01, 2014, indicating that the tenants are obligated to pay \$1,200.00 in rent in advance on the first day of each month;
- A copy of a 10 Day Notice to End Tenancy for Unpaid Rent issued on August 19, 2014, with a stated effective vacancy date of August 29, 2014, for \$6,200.00 in unpaid rent effective August 02, 2014, and
- A copy of the Proof of Service of the Notice to End Tenancy showing that the landlord personally served the notice to end tenancy on the tenants on August 19, 2014.

The Notice restates section 46(4) of the Act which provides that the tenants had 5 days to pay the rent in full or apply for Dispute Resolution. The tenants did not apply to dispute the Notice to End Tenancy within 5 days from the date of service and the landlord alleged that the tenants did not pay the rental arrears.

<u>Analysis</u>

I find that the tenants received the notice to end tenancy on August 19, 2014. I accept the landlord's evidence and I find that the tenants neither paid the rental arrears, nor applied to dispute the notice. The tenants are therefore conclusively presumed to have accepted that the tenancy ended on the effective date of the notice. I grant the landlord an **order of possession** which must be served on the tenants. Should the tenants fail to comply, the order may be filed for enforcement in the Supreme Court.

I accept the evidence before me that the tenants have failed to pay a total of \$6,200.00 in rent effective August 02, 2014. I find that the landlord is entitled to recover the rental arrears. In his application the landlord has reduced the amount of unpaid rent sought to \$5,000.00, in order to avoid paying a higher filing fee. Following from all the foregoing, I grant the landlord a **monetary order** in the amount of **\$5,000.00**.

Conclusion

I hereby issue an **order of possession** in favour of the landlord effective not later than **two (2) days** after service on the tenants. This order must be served on the tenants. Should the tenants fail to comply with the order, the order may be filed in the Supreme Court of British Columbia and enforced as an order of that Court.

Pursuant to section 67 of the Act, I hereby issue a **monetary order** in favour of the landlord in the amount of **\$5,000.00**. This order may be served on the tenants, filed in the Small Claims Court and enforced as an order of that Court.

This decision is made on authority delegated to me by the Director of the Residential Tenancy Branch under Section 9.1(1) of the *Residential Tenancy Act*.
